# 2013-2014 Minimum Health Requirements for Chicago Public Schools

The Chicago Board of Education recognizes the relationship between academic achievement and access to health promotion and prevention activities. Healthy students have better attendance and perform better in school. The following health requirements apply to all children enrolled in a Chicago Public School. **Children must provide proof of required immunizations and health exams before October 15, 2013**, or they will face exclusion from school.

**Physical Examination** requirements due upon enrollment, **no later than 10/15/13** 

Physical Examination must be completed within one year prior to entry to:

- Any Chicago Public School for the first time, at any grade level
- 6th grade and 9th grade (ages 6, 11, 15 for un-graded programs)
- Preschool and kindergarten (physical exam and lead screening through age 6)

#### <u>Vision Examination</u> requirements due upon enrollment, <u>no later than 10/15/13</u>

- Entering the State of Illinois for the first time at any grade level
- Entering kindergarten

**Dental Examination** requirements due upon enrollment, no later than 5/15/14

• Entering kindergarten, 2nd grade, and 6th grade

# **Immunization Requirements**

### Diphtheria, Pertussis (Whooping Cough), Tetanus (DTaP/Tdap)

- Four (4) or more doses for preschool, kindergarten, or 1st grade; three (3) or more doses for all other grades
- The last dose qualifying as a booster and received on or after the 4th birthday
- <u>NEW</u> for the 2013-14 school year children entering 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup> and 12th grades will be required to show proof of receiving one-dose of the Tdap vaccine

#### **Polio Virus** (Polio Vaccine)

- Three (3) or more doses of a polio vaccine before entering school at any grade if inactivated vaccine used, exclusively. Four (4) doses are required at any grade if inactivated and oral polio vaccine are given in combination.
- The last dose qualifying as a booster and received on or after the 4th birthday

#### Measles

- One (1) dose required for preschool, and two (2) doses required before entering any other grade
- 1st dose received at 12 months or later
- 2nd dose of measles vaccine must be administered at least 1 month after 1st dose

# **Mumps and Rubella**

- One (1) dose of each before entering any grade
- 1st dose received at 12 months of age or later

#### **Hepatitis B**

- Three (3) doses required before entering any grade (first dose received at birth or later)
- 2nd dose received at least 1 month after 1st dose
- 3rd dose received at least 2 months after 2nd dose, and 4 months after 1st dose

#### Varicella (Chicken Pox)

• One (1) dose required on or after the first birthday (not required after 11th grade)

#### Haemophilus Influenzae, Type B (HIB)

- Two (2) or more doses required for students entering any preschool or pre-kindergarten program (not required for children 5 years of age or older)
- Only one (1) dose required if first dose administered at or after 15 months of age
